

Tax Lien Fraud: ". . see how deep the rabbit hole goes . ." — continued

On August 7, 2007, once again Rae Copitka and Loma Wharton have appeared before the Douglas County Commissioners. This time the Commission had brought in a hired gun, a supposed expert to testify.

The first meeting took place on August 8, 2007, click on Media Player and advance to 7min. 41sec..

The second meeting took place on August 29, 2007, click on Media Player and advance to 23min. 37sec..

The third meeting took place on September 7, 2007. The entire recording is on the issues Rae and Loma are pursuing.

In the third video the meeting is started with announcements concerning who will be appearing and for whom they are appearing. A supposed expert will be testifying before the Commission, revealing their expertise.

You will note that some of the words being used by the expert have suffered revision to their definitions. Words such as Law, Code, Color of Law, all have been redefined to mean something that serves the expert while abandoning their true definition.

“Color of Law” as defined by “Black’s Law Dictionary”, 6th Edition.

Color of Law. The appearance or semblance, without the substance, of legal right. **Misuse of power**, possessed by virtue of state law and **made possible only because wrongdoer is clothed with authority of state**, is action taken under "color of state law."

When used in the context of federal civil rights, statutes or criminal law, the term is synonymous with the concept of "state action" under the Fourteenth Amendment, and means **pretense of law**, and includes actions of officers who undertake to perform their official duties.

Nowhere in the testimony of Ms. Nina Cook is this phrase defined the same as in “Black’s Law Dictionary”, 6th Edition. Her definition does not come close to anything that resembles Black’s definition. Ms. Nina Cook has revised the definition to serve herself and her alleged expert testimony. Sophistry!

Law, has two forms, common law and statutory law. Common Law is what the courts have said the law is, while statutory law is what the legislature or Congress has said it is.

Code, is a privately indexed cataloged of statutes and common law, it is a reflection of the law, not the law.

During Loma's presentation, Loma puts the county commissioners on notice that if the Notice of Federal Tax Lien is not filed in an index that prohibits them from becoming a negotiable instrument, actions will be taken against the commissioners and that action will be on a personal level.

What is underneath this notice but not said is that the county can do nothing; it is an inanimate creature. It takes people to do something. Only people can perpetrate acts, and thereby only people can create damages by their acts.

What is being requested that the notices of lien be placed into an index that does not convert the notices into a negotiable instrument, a lien. If the IRS wishes to file an actual lien, then the IRS needs to follow not only its own guidelines, it must also follow the guidelines as they are laid out in the Uniform Lien Registration Act, none of which are being adhered to.

A movement is started.
